Manager Aldrich Memo. Jennifer Levins from the CTC (Communities That Care) program will be at our meeting to update Council on their program and activities. Jennifer shared what the Vision Statement is for the CTC. "A family-oriented community committed to fostering engaged and resilient youth." Jennifer provided a packet showing a recent Community Assessment Report. This packet shows that the following risk factors were identified as priorities for community attention: Perceived Risk of Drug Use (Peer/Individual Domain) and Depressive Symptoms (Peer/Individual Domain) The problem behaviors that were identified by the survey as more pronounced in Schoolcraft County than the national norm were as follows: Substance use/abuse, especially alcohol, riding with a drinking driver, and Chewing tobacco use. The CTC has 7 work groups that are working towards their goals.
